Commissioner Dickinson opened comment from the Floor and stated that because the guests are not on the agenda Commissioners cannot comment on their topic.

Comments from guests, Raymond Grundhoefer and Sandra Baggot, 28729 Mulberry Lane — When they bought the property in 2009 they were told they would pay \$4600 for the sewer lateral. When they began building in 2014 they were told it was \$5800 for the sewer lateral permit. They are requesting a refund of \$1200 since they were never notified of the increase in cost.

Commissioner Dickinson stated he would check into the sewer lateral fees but that the fee did not go up. Developed subdivisions in the area are at a lower rate because the developer paid a portion of the fee. The fee is for the maintenance of the infrastructure and for the reserve fund.
